## A. Non-union Employee Compensation

Supervisor Scott obtained comparables from other communities and shared them with the Board.

Trustee Weber explained the Non-union Employee Compensation Committee's process and their recommendations.

Their objective is as follows:

- Retain great employees at all levels
- Recognize the work employees have done
- Reward employees for their performance
- Motivate employees to continue to improve

## ITEM 5:11-17 APPROVAL OF 2021 TOWNSHIP BUDGET (Non-union Employee Compensation continued)

Trustee Sovel said the committee does recognize the comparables submitted by Supervisor Scott but they feel they did not have enough time to do a full evaluation by setting individual goals or department objectives. They hope to implement these in the first quarter of 2021. Because of the economy, COVID19 pandemic, business being closed and shutting down, to increase the numbers by 20-30% seems excessive to do in one year. It may take a year or two to get to the comparable numbers.

Trustee Magner said Trustees Weber and Sovel explained everything correctly. The committee also talked about developing some ranges they would like each position to be in, but there was no time to do that. They would like to focus on that next year.

Discussion took place on salaries for non-union employees. In place of naming employee positions, the committee recognized the positions as numbers 1-9.

## C. Conditional Rezoning Petition for 3144 Martin Road

Planning Director David Campbell said this is a petition to conditionally rezone a piece of property on the east side of Martin Road between Township Drive and Oakley Park Road. It is a former driving range property with an office along Martin Road frontage. Pulte Homes hopes to conditionally rezone that property to redevelop it with 103 attached townhomes. The property is currently zoned TLM (technology and light manufacturing) and they want to retain that base zone but take the Towne Center (TC) overlay and extend it one property north to encompass this property. The TC Overlay allows for a residential development where the base zoning of TLM does not. This

request is consistent with the Township Master Plan. The Planning Commission recommends approval. If the Township Board approves the Townes at Merrill Park's conditional rezoning petition Pulte would then return to the Planning Commission in the near future for approval of a fully-developed site plan for the owner-occupied attached townhome condominiums.

William Anderson, Project Engineer, Atwell LLC, gave a presentation of the Martin Parkway Townes. Joe Skore, Vice President of Land, Pulte Group of Michigan, LLC, was present.

#### ITEM 12:11-17 OTHER MATTERS

Supervisor Scott -

- Outrun Hunger refund of their security deposit.
- Union Lake Boat Launch he has been in communication with the real estate division of the DNR. They have initiated the process to get the appraisal done. He asked them to look at the value of the boat launch and the parking lot to see if the Township only wants the boat launch site. The boat launch is not a buildable site. We should see a response from the DNR in 60-90 days. We agreed to pay for the appraisal cost. If the Township does not purchase the property, they will refund us the appraisal cost from the sale of the property. He sent communication to Jim Runestad and Ryan Berman to look at the opportunity for us to have a Lame duck session where the legislature in Lansing may convey this property to us at a reduction and not fair market value.
- COVID-19 update because of Governor Whitmer's new COVID limitations for Michigan, activity at Township Hall has gone back to almost nothing. The Board may want to assist Supervisor Gray to come up with a way to potentially close the north entrance and only allow people to come in the east entrance.
  Additionally, restrict access to the building by appointments only to help reduce contact with employees.

## Trustee Berkheiser -

- Asked for an update from Dave Campbell on the Marathon station. He did not think the property to the south and east could be a gas station. Dave Campbell said the property the gas station currently sits on is split zoned. The front half of it is zoned B3 and the back half of the property is zoned R1D. They refigured their plans and do not need a rezoning now.
- Swearing in for Township Board of Trustees will be on Thursday, November 19, 2020 at 5:30 at the Township Hall.

#### Trustee Weber -

 Outrun Hunger – 51 volunteers did a great job. The event was staged in four different heats, everyone wore masks and stayed 6' apart and went in 20-minute increments. They had 249 racers,113 donors that contributed and 12 sponsors. They contributed \$22,189.00 that will provide 1,100 families with a warm Thanksgiving and Christmas meal in our area. ## Trustee Magner –

 She noticed bikers and joggers are darting out into the roadway from the bike trails, especially at Benstein Road and the trail close to Maple Road. Supervisor Scott said Michigan Air Line Trail and The Road Commission for Oakland County have done extensive education and signage on how to cross roadways from the trails.

#### Trustee Sovel -

 Asked for an update on Cascade. Treasurer Phillips said this will be on the January agenda.

## Treasurer Phillips –

 Tax collection will begin December 1, 2020. They will put a small flyer in the tax bills that are mailed to people that do not pay their taxes through a mortgage company advising them if they cannot come into the Township to pay their tax bill, they can make an appointment and we will make arrangements to assist them.

• Volunteers put in approximately \$80,000 worth of landscape at Scarlet's playground. The pavement is complete.
