ITEM 7:7-13 OLD BUSINESS

A. Old Boat Launch on Union Lake

MOTION by Gray, supported by Sovel, to purchase the old boat launch and parking lot property on Union Lake Road from the DNR for an amount not to exceed \$365,000. Funds to come from the General Fund. **MOTION CARRIED UNANIMOUSLY**

B. Township Property Management and Strategy Sub-Committee Trustee Weber gave an update on the Sub-Committee's findings for 166 properties owned by Commerce Township. They recommend the next steps:

- Township Board to Review and approve language for sample letters for: 4.1 &
 4.2 Parcels, Whitlow Blvd/Hospital parcel and the Reed Lake parcels.
- Township Board to approve proposed pricing for Category 4.2 parcels.

July 13, 2021

ITEM 7:7-13 OLD BUSINESS (Township Property Management and Strategy Sub-Committee continued)

- Township Board to direct Building and Planning Directors to develop and execute RFQ for Category 4.3 parcels (RFQ to include price estimate for each lot and capability for realtor to purchase all parcels, or sell each. Must bid on all parcels).
- Township Board to direct Planning and Building Directors to develop and execute RFQ for 4.4 parcel (Rose Button).
- Meet with WLCSD to discuss potential for Category #4.5 parcels.

Trustees Berkheiser and Sovel have concerns with bullet # 3 for the 4.3 "buildable lot" parcels. They feel whatever offer is received should come to the Board for approval. They are not opposed with going out for a RFQ but believe the board should be part of the sale price approval process for the identified parcels

Trustee Weber agrees and suggested the Planning and Building Directors develop a draft RFQ outlining the process in greater detail, and discuss this at the next Board meeting. He would also like the Township Attorney to review the draft letters.

MOTION by Weber, supported by Berkheiser, to approve the language for sample letters for: 4.1 & 4.2 Parcels, Whitlow Blvd/Hospital parcel and the Reed Lake parcels, approve proposed pricing for Category 4.2 parcels and send letters to adjacent property owners, direct the Planning and Building Directors to develop and execute RFQ for 4.4 parcel (Rose Button) and meet with WLCSD to discuss potential for Category #4.5 parcels.

MOTION by Weber, supported by Sovel, to direct the Building and Planning Directors to develop a draft RFQ for Category 4.3 parcels and forward it to the Township Attorney for review and present it at the next Township Board of Trustees Meeting.

C. Library of Michigan ARPA Grant Program

Alyson Lobert, Library Director, is asking for approval to apply for the ARPA Grant administered by the Library of Michigan in the amount of \$38,010.00 to install a standalone library kiosk in a senior living facility. This will provide senior residents a way to independently check out materials.

MOTION by Magner, supported by Sovel, to approve the request of the Library Director to apply for the ARPA Grant administered by the Library of Michigan in the amount of \$38,010.00 for a stand-alone library kiosk. **MOTION CARRIED UNANIMOUSLY**

D. Wixom Road Horse Farm

Jay James, Building Director, recommends contracting with Wyckoff Well Drilling and Mills Electric to relocate the well bladder and equipment at the Wixom Road Horse Farm.

ITEM 7:7-13 OLD BUSINESS (Wixom Road Horse Farm continued)

MOTION by Weber, supported by Sovel, to contract with Wyckoff Well Drilling and Mills Electric (Township Maintenance Department will purchase the required lumber) to relocate the well bladder and equipment at the Wixom Road Horse Farm in an amount not to exceed \$10,000. **MOTION CARRIED UNANIMOUSLY**

ITEM 8:7-13 NEW BUSINESS

A. Byers Farmhouse Restoration

Emily England, Senior/Parks and Recreation Director, said the Parks and Recreation Committee recommends the Board move forward with the repair of the Byers Homestead by the Dailey Company in the amount of \$141,900 to make the house structurally sound and safe. She does have concerns with Dailey Company excluding a professional liability insurance policy from their bid.

Discussion took place on what the cost would be to add professional liability insurance to Dailey Company's bid.

MOTION by Weber, supported by Berkheiser, to contract with the Dailey Company for the restoration of the Byers Homestead Farmhouse and include a professional liability insurance policy in the bid. The total amount shall not exceed \$150,000.

B. Alcoholic Liquors Special Permit Applications by Multi-Lakes for Rocking Under the Stars, Annual Good Old Days, and Freedom Festival Events

MOTION by Phillips, supported by Creech, to approve the Application Alcoholic Liquor Special Permit to Multi-Lakes Conservation Association for Rocking Under the Stars, Annual Good Old Days, and Freedom Festival Events on August 28, 2021 from noon to midnight.

C. Annual Approval of Act 152

MOTION by Sovel ,supported by Magner, to exempt itself from the requirements of Michigan Public Act 152 of 2011 from a 80/20 Health Care Plan to a 90/10 (Township pays 90% and employee pays 10%) Health Care Plan, Township wide.

D. DTE Electric Company Underground Easements (Rights of Way) – Fire Station No. 3

Hans Rentrop, Township Attorney, said the easements have already been signed by Supervisor Gray to avoid holding up construction. He recommends the easements be formally recognized and ratified by the Township Board.

MOTION by Sovel, supported by Magner, to approve and ratify DTE Electric Company Underground Easement (Right of Way) No. 61325324-61401119 and DTE Electric Company Underground Easement (Right of Way) No. 61325324-61401178 and to authorize Supervisor Larry Gray's signature thereto to enable electrical connections to Commerce Township Fire Station No. 3.

ITEM 10:7-13 OTHER MATTERS

Trustee Weber -

- Asked Fire Captain Liker if the Fire Dept is satisfied with the services provided by Star EMS because their call-time metrics have been slower than the previous supplier. Captain Liker said response times have increased, but the Fire Dept believes the level of care has improved and resident complaints have decreased.
- Historically, Fire Chief Dundas would give the Board a report that would detail Fire Dept service metrics. We have not been receiving the level of detail required and requests this be included in all future Board materials.
- He asked about the process to discuss a "smart" light at the Richardson / Martin Road intersection which could dramatically reduce wait times. Supervisor Gray advised he has started the process with the RCOC.

Trustee Berkheiser –

- Asked for an update on the toilets backing up at the new restroom facility at Dodge Park. Jay James and Jason Mayer are working on this.
- He would like to hold a joint meeting between the Planning Commission and the Township Board of Trustees.
- Asked Library Director Lobert if the library is holding a Music in the Parks event. She said they are having one concert on July 14, 2021.

Trustee Magner -

- Will there be a July Township Board Quarterly Meeting? Clerk Creech said yes it will be a joint meeting with the Parks and Recreation Committee.
- Will we discuss Department Directors purchasing authorities without Board approval? Clerk Creech has that listed on her draft for the agenda.
- When will budget discussion meetings be held? Supervisor Gray said they will be held in September and October, 2021.

ITEM 10:7-13 OTHER MATTERS continued)

Supervisor Gray -

- The Transportation, Housing and Urban Development Committee has approved 2 million dollars for the Lystek System. The next step is it will go to the Full House of Appropriations Bill for approval.
- You might start seeing bills from the Water Resource Commission in the Orders and Add Ons. The Water Resource Commission was billing residents direct for repairs instead of billing the Township. They were supposed to bill the Township and the Township then bills the residents. Jay James said this is for Woodbridge Lake Estates only.
- Two part time Ordinance Officers were hired.
- A DDA Assistant was hired for the DDA Director.
- He is working with Hans Rentrop, Township Attorney, on verbiage so people will not take wildlife away from Township parks.
