A. Lease Amendment – Long Park Cell Tower Site

Jay James, Building Official, and Phillip Adkison, Township Attorney, explained the Amendment.

MOTION by Weber supported by Berkheiser, to approve the lease Amendment for Long Park Cell Tower Site as identified in the Township Attorney's letter dated June 5, 2019.

ITEM 5:6-11 OLD BUSINESS (continued)

B. Fire Station 3 – Plante Moran CRESA Agreement for Owner's Representative Services

Hans Rentrop, Township Attorney, advised the Board that Plante Moran CRESA (PMC) has requested changes to the Agreement for Owner's Representative Services" ("Agreement") and the "Charter Township of Commerce Mandatory Insurance and Indemnification Rider". It is his opinion that the changes requested by PMC are not specifically deal breakers. However, they are contrary to (a) the documents set forth in the RFP, and (b) the Township's standard insurance Rider requirements. The changes also increase liability risks to the Township. The specific provisions of concern are:

- PMC has requested that both parties waive incidental and consequential damages for claims that arise out of the Agreement. The waiver will apply to all consequential damages including those due to either party's termination of the Agreement.
- 2. The Township's standard Rider, which was approved as part of the Township's policy on contractor's insurance requirements, includes a provision that requires any certificate of insurance to contain a provision requiring notice be provided to the Township if insurance is cancelled for any reason. PMC's insurance carrier will not provide such a condition. The carrier will notify PMC if termination will be made for some types of insurance provided that the termination is not the result of PMC's failure to pay premiums.
- 3. The Township's Rider includes an "Agreement to Defend, Indemnify and Hold Harmless" the Township for work performed by the contractor. PMC has requested that this be limited to negligent and willful misconduct of its actions, that of its employees and anyone else for whom PMC may be liable. We have no objection to this change, especially since PMC will not likely be performing any construction work.

Trustee Weber has issues with the changes in the Agreement because it absolves PMC from any accountability. The changes in the Agreement was not presented to the Township Board as part of the RFP. He would like the Board to discuss this in depth with PMC.

Trustee Sovel is in agreement with Trustee Weber.

Kevin Donnelly, Vice President Plante Moran, was present and stated he is not the person that can address this issue but he will inform the responsible party so they can address the issues. He is willing to engage in further discussion.

Supervisor Scott stated PMC needs to honor the RFP and recommends we send this back to the Township Attorney and request they report their findings to the Township Board.

Jay James, Building Official, said the Board could approve this subject to terms that PMC will honor the RFP so we do not have to wait another month for approval.

Trustee Weber questioned if the Board would consider authorizing the sub-committee to make and sign changes to the agreement.

ITEM 5:6-11 OLD BUSINESS Fire Station 3 — Plante Moran CRESA Agreement for Owner's Representative Services (continued)

MOTION by Scott, supported by Magner, to approve the Charter Township of Commerce Mandatory Insurance and Indemnification Rider subject to Plante Moran CRESA honoring the RFP in accordance with changes made by the Township Attorney to the Agreement. In addition, the sub-committee made up of George Weber, Robert Berkheiser and Supervisor Scott will have the authority to review and finalize the Agreement.

A representative of Outreach Hunger requests the fee for use of Township property be rounded off to \$1,000.00.

Trustee Berkheiser said they will use the facility for 2 hours on Friday and approximately 5 hours on Saturday. He has no problem charging them a fee for half a day instead of a full day.

Treasurer Phillips feels we should adhere to the Township Policy.

Trustee Sovel would like a commitment from the petitioners to use Commerce Township as the address for the business. The petitioners both said all of their marketing shows Commerce Township as the address. He will continue to do so as long as it is under his control. He said sometimes when someone googles the restaurant he will come up as Walled Lake which he has no control over.

B. Acuity Optics and Medical Eye Care 5K at Dodge Park

Emily England, Senior Director, advised the Board that Acuity Optics and Medical Eye Care are requesting to hold a 5K Run at Dodge Park on August 18, 2019. They would like to reserve the pavilion area starting at 7:00 a.m. The race starts at 8:00 a.m. and will end around 10:00 – 10:30 a.m. The Parks and Recreation Committee recommended approval to the Township Board at their meeting on May 20, 2019. The run will be moved to the north section of the park.

Edwin Gay, O.D. Acuity Optics and Medical Eye Care, was present.

Trustee Berkheiser would like some type of confirmation of who will receive the proceeds from the 5K run.

Hans Rentrop, Township Attorney, said the Township does not have an Ordinance at this time requiring submission of Trustee Berkheiser's request.

Edwin Gay said he will have a separate bank account for the funds received from the 5K run and they will go directly to the charity. He can provide a statement, as requested by Trustee Berkheiser, to the Township Board.

MOTION by Weber, supported by Berkheiser, to approve the 5K Run requested by Acuity Optics and Medical Eye Care at Dodge Park on August 18, 2019 subject to proof of insurance and a statement showing the funds were received by the charity chosen by Acuity Optics and Medical Eye Care.

Discussion – The Parks and Recreation Committee should work on a policy for charity events held at/on Township property.

Hans Rentrop, Township Attorney, advised the Board to carefully administer the project, the agreement comes with many stipulations on the timeline for projects.

D. Benstein Road Water Main Extension- Phase One

Jason Mayer, PE Giffels Webster, is requesting approval to move forward with the Design Engineering portion of this project at a cost not to exceed \$173,800. He will present a contractor award recommendation and final project costs for approval at a future Board meeting with a planned 2020 construction.

G. Master Agreement for Municipal Street Lighting

Hans Rentrop, Township Attorney, explained the agreement between DTE Electric Company and the Charter Township of Commerce.

MOTION by Berkheiser, supported by Weber, to approve the Master Agreement for Municipal Street Lighting between DTE Electric Company and the Charter Township of Commerce along with a \$575 annual estimated cost for annual lamp charges and authorize the appropriate signatures.

Lieutenant Schroeder said there were more problems this year at Walled Lake Western High School and the new "Vape Ordinance" increased the numbers.

Trustee Weber questioned if the Township should create some type of transition team to help with the change to a new waste management company (GFL).

Supervisor Scott is interviewing for a new maintenance employee.
