Patrick Juras, Lakes Athletics Treasurer, said the repairs deal with the runoff of water from the field and the washout it is causing at one of the dugouts.

Trustee Weber said he visited the site and it appears the washout is caused by boards that were placed below the backstop and the way the field was graded. He said the Township is responsible for anything outside of the fence and the leagues are responsible for anything

inside the fence which surrounds the fields. If we approve this, it will set a precedence for other leagues to ask the Township to pay for repairs.

Trustee Weber reviewed the Parks and Recreation Meeting minutes and did not see where Byers was discussed in the conversation under league contracts. Emily England, Senior Director said Byers was at the meeting and they will receive a copy of the contract.

Trustee Berkheiser said the Hunger Race was a success and he thanked everyone for their support. He will provide a summary of the race in the near future.

Trustee Magner asked if the board will discuss banner guidelines. Supervisor Scott said the Planning Commission will discuss this during their next meeting.

Trustee Magner would like the board to discuss guidelines for improvements made to Township property. She would like to see some type of consistency and not give special treatment to certain leagues/groups.

Supervisor Scott said the DNR found 27 illegal hunters on Township property. The hunters were told not to hunt on Township property and to remove hunting blinds they put up.

Treasurer Phillips said a committee was formed to oversee the concession agreement for the horse farm. They received a copy of Maybury State Park's concession agreement to review. Ron Campbell from Oakland County will visit the site and give his recommendation to the committee. Treasurer Phillips asked if the money the Township is spending toward the new Fire Station should be considered "receivable" from the Fire Department and not expensed. Trustee Sovel asked if the General Fund should charge the Fire Department interest (like they

do the DDA). Yes, it is due back to the General Fund and no, there shouldn't be interest charged.

Supervisor Scott asked Fire Chief Jim Dundas how many applications were received for the firefighter position. He answered 74 applications filtered down to 47 to interview.

Trustee Magner asked if the Township pays for paid on call firefighter training. Fire Chief Dundas answered they will send them for training if they are a Commerce Township resident.
