This will codify additional minimum requirements for engineering plans submitted to the Township, update and revise stormwater management regulations consistent with new State law requirements, and update and revise the Township's paving engineering design standards regarding non-public roads, and sidewalks.

A. 2025 Township Budget

Supervisor Gray asked the Board if they had any questions regarding the budget.

Treasurer Phillips asked what department the ADP costs will go into. Katelyn Massey said they will go into the General Fund.

Trustee Weber asked if approval of the budget will take place on Monday, November 18, 2024 and if the Public Hearing notice has gone out. HR/Finance Director Massey and Supervisor Gray answered yes.

B. 2025 Elected Officials' Wages

Trustee Weber said both Directors and Elected Officials should receive a 6% raise due to recognition of performance as well as from a competitive standpoint to make sure we are in the ballpark with our competitive communities.

Supervisor Gray recommends \$300 per meeting for Township Board of Trustees.

Discussion: Trustee Weber said this is a very high percentage rate. His personal view is the Trustees are doing this as a service to the community, not so much for the pay. He would like to keep the rate the same at \$250 per meeting.
