## **ITEM 7:7-9 OTHER MATTERS**

Trustee Weber --

- What is the County's plan (road closure, timing, signage) for installation of the culvert on South Commerce at Glengary Roads? Supervisor Gray said installation is to begin July 10, 2024 and completion date expected to be the end of August 2024. This will be announced on social media and Supervisor Gray will follow up with The Road Commission for Oakland County to discuss signage to be put up, advising the public as to when the road will be closed.
- He is not sure the Police SAD funding will support what the Sheriff's Department
  is asking for toward increased costs for services. We may want to have a small
  group review this before the budget process starts to ensure we understand the
  impact.

## ITEM 7:7-9 OTHER MATTERS (Trustee Weber continued)

- FYI to Chief Dundas He noticed the calls for fire service are down by double digit percentage for Stations 1, 2 and 4 but up for Station No. 3. Chief Dundas said Station No. 3 handles the busiest area in the Township.
- Can OHM Advisors include the impact of the proposed development of Union Lake and Richardson Roads in their traffic study? Future Bay Point and Drive-In developments in that area may have a significant impact on traffic.
- Cyber security/phishing attacks Is Ben Sebrowski still working on educational training for employees? Supervisor Gray answered yes.

#### Trustee Berkheiser -

- When and if Costco purchases Ghost Handcrafted Tacos & Cocktails property, will the liquor license come back to the Township? Hans Rentrop said it is a DDA Liquor License and if the business closes, the license is terminated.
- He is not happy with Midtown Haggerty wanting to convert the apartment complex to a Kroger store. Dave Campbell said the concept was brought to the Planning Commission; no changes made at this time.

## Trustee Sovel -

• FYI – He read that the City of Northville is getting a 50,000 sq. ft., 16 indoor court pickle ball facility.

# Trustee Magner –

• Over the next couple of months, she will not be able to attend at least three (3) Library Advisory Board (LAB) meetings. If the Township Board would like to replace her with another Township Board member, she would be willing to resign from the LAB. Budget discussions will be coming up soon. No action taken.

# Supervisor Gray -

- He gave the school's Liaison Officer the red-lined version of the contract for review.
- A new business in the Township called "Book Love Barn" would like to know if the Township will give them a quota liquor license. He asked the owners to appear before the Township Board. Hans Rentrop advised the Board "Book Love Barn" needs to be a viable business that will remain open for a long time. If the business closes, the license will be terminated and may not revert to the Township. Mr. Rentrop will investigate this and report back to the Board.
- The price to repair faulty check valves in Township buildings will be \$5,400.
- The Township's insurance policy will go up 40% in cost. We will be looking into other insurance providers.
- A few residents would like to move forward to form a volunteer welcoming committee for new residents moving into the Township. The residents requesting the committee will appear before the Township Board soon to discuss their idea.
