ITEM 4: Road Grant Opportunity Resolution

Supervisor Gray said he and the work group met with OHM last week and they are looking at the intersection of Martin Parkway and Richardson Road, and Union Lake and Richardson Roads. They have some ideas on how to improve those intersections but it will cost around \$5 million. SEMCOG has the Congestion Mitigation and Air Quality (CMAQ) Improvement Program and Carbon Reduction Program (CRP) that presents a grant opportunity for the Township.

ITEM 4: Road Grant Opportunity Resolution continued

MOTION by Sovel, supported by Magner, to authorize the Township Supervisor to execute the Sponsorship Agreement between the Road Commission for Oakland County and Commerce Township and submit the funding application for congestion mitigation and air quality (CMAQ) funding for the construction of intersection improvements at Richardson and Martin Roads and at Richardson and Union Lake Roads.

MOTION CARRIED UNANIMOUSLY

Supervisor Gray said we are trying to fight the Oakland County Sheriff contract and trying to spread the 15% increase over the next 3 years but they are looking to increase the 2025 contract by 15% as well, which would be a \$935,000 increase. For years 2026 and 2027 they are proposing CPI plus 6% which is close to a 33% increase over the next 3 years. Supervisor Gray and several other township supervisors are attending the County Board of Commissioners' meeting on Thursday. He wants clarification of the additional 6%.
