# ITEM 4:10-8 Contract Awards and Agreements

# A. Victory Park Dog Park Fencing Contract Award

Director Emily England reviewed the project with the Board. She said an anonymous person would like to donate a \$50,000 check to the township to go towards this project.

Jason Mayer, Giffels Webster, said bids for the Victory Park Dog Park Fencing project were received on August 27, 2024 at 4:00 pm. and were opened publicly and read aloud. A total of two (2) bids were received. The low bid was submitted by American Fence & Supply Co, Inc. based in Warren, MI at \$144,220.00. The second lowest bid was submitted by RMD Holdings, Ltd. at \$156,434.00. Based on experience, qualifications, our review of references, and their submittal of the lowest responsive bid, we recommend that the Victory Park Dog Park Fencing Project construction contract be awarded to American Fence & Supply Co, Inc. in the amount of \$144,220.00.

**MOTION** by Sovel, supported by Creech, to accept the monetary donation for the Victory Park Dog Park Fencing and to allow naming rights.

Trustee Weber will abstain from the vote because he knows the person donating the money for the project.

MOTION by Magner, supported by Creech, to award the Victory Park Dog Park Fencing Contract to American Fence & Supply Co, Inc. in an amount not to exceed \$145,000.00.

B. Intergovernmental Agreement – Cooley Lake Aquatic Weed Control Hans Rentrop, Township Attorney, said State law allows two townships to enter into an agreement to treat a lake for aquatic weeds when the lake is in more than one township. The proposed Agreement has been drafted and reviewed by White Lake's and Commerce Township's attorneys and it is substantially the same to that which the Board previously approved when it first established this SAD in 2016. All benefitted properties will be assessed \$118.00 per year which includes the administrative fees. Each township shall retain the administrative fees collected from properties within their own jurisdiction. The agreement will be approved by White Lake Township during their October 2024 meeting.

ITEM 4:10-8 Contract Awards and Agreements (Intergovernmental Agreement-Cooley Lake Aquatic Weed Control)

**MOTION** by Weber, supported by Sovel, to approve the Intergovernmental Agreement for The Control of Aquatic Weeds in Cooley Lake Between The Charter Townships of White Lake and Commerce, subject to acceptable insurance language and policy in place. **MOTION CARRIED UNANIMOUSLY** 

#### **ITEM 5:10-8 INTRODUCTIONS**

A. An Ordinance to Amend Ordinance to be Known as Code Amendment Ordinance No. 1.072 – To Codify the Prohibition of Non-Storm Water Discharges into the Township's Storm Sewer System.

Hans Rentrop, Township Attorney, said this will codify the prohibition of non-stormwater discharges to a storm sewer watercourse in accordance with State law. Additionally, the proposed Ordinance amends Appendix B (Engineering Design Standards) to codify the minimum requirements for engineering plans submitted to the Township, to update and revise the stormwater management regulations to be consistent with new State law requirements, and to update and revise the Township's paving engineering design standards regarding non-public roads and sidewalks.

Jason Mayer, Giffels Webster Engineers, explained the engineering changes to the Ordinance.

MOTION by Sovel, supported by Phillips, to Introduce an Ordinance to Amend the Code of Ordinances, Charter Township of Commerce, Oakland County, Michigan to be Known as Code Amendment Ordinance No. 1.072, post and publish according to law.

#### **ITEM 6:10-8 ADOPTIONS**

A. An Ordinance to Amend Ordinance No 2.028 to be Known as Fee Ordinance No. 2.029

Hans Rentrop, Township Attorney, said there were no changes made from the time this was Introduced.

**MOTION** by Sovel, supported by Creech, to Adopt an Ordinance to Amend Ordinance No. 2.028 to be Known as The Charter Township of Commerce Fee Ordinance No. 2.029, post and publish according to law.

B. An Ordinance to Amend Article 2, Section 2.02 and Article 26, Section 26.316 of Zoning Ordinance 3.000 to be Known as Zoning Amendment Ordinance No. 3.066 – OPASO Text Amendment

Hans Rentrop, Township Attorney, said the concept behind the amendment is to reduce the total number of off-premises alcohol sales outlets.

ITEM 6:10-8 ADOPTIONS (An Ordinance to Amend Article 2, Section 2.02 and Article 26, Section 26.316 of Zoning Ordinance 3.000 to be Known as Zoning Amendment Ordinance No. 3.066 – OPASO Text Amendment continued) This amendment includes the following changes:

- A grammatical correction changing reference from "off-premise" to "off premises."
- Revises the application requirements to (a) require site plan review, a copy of the State-issued liquor license, a floor plan, and a map showing the location of other OPASOs for all applications; and (b) require special land use approval for all applications unless otherwise listed as an exception under the Amendment.
- Clarifies how the distances are measured when an OPASO is within 500 feet of a place of worship, public park, licensed daycare facility, pre- and/or K-12 school.
- Allows for the expansion of an existing OPASO if it results in a reduction in the
  total number of OPASOs within the Township and (a) the license used to expand
  the existing use is transferred from another OPASO that is within 1,000 feet of
  the expanding OPASO; (b) the OPASO from which the license is transferred
  ceases alcohol sales permanently; (c) there is no physical expansion of the
  OPASO to which the license is transferred; and (d) the transfer of the license
  does not adversely impact traffic.

The Planning Commission voted 5-1 to approve the Amendment.

Trustee Weber explained why the Planning Commission approved the Ordinance. This will mainly affect the Union Lake corridor and Commerce Village.

Joseph Shallal, Esq. said the reason the 1,000 feet was chosen was because they wanted to take licenses out of a certain area. If you have two businesses on the same street, one license will be eliminated. This is good because the density of the number of licenses servicing that area is reduced.

Discussion ensued on how the amendment will benefit the township.

department. The mural will have a woodlands theme, as we want to highlight our library's unique location within beautiful Dodge Park. It will be prominently located on the west wall of the youth room. The total cost of the mural is \$5,400. The first payment, \$2,700, will come from the library's 2024 budget. The second payment, \$2,700, will come from the library's 2025 budget.

MOTION by Magner, supported by Creech, to approve the recommendation of the Library Advisory Board to allow artist Rhiannan Sibbald to paint a mural in the youth department in an amount not to exceed \$5,400. The first payment, \$2,700, will come from the library's 2024 budget. The second payment, \$2,700, will come from the library's 2025 budget. **MOTION CARRIED UNANIMOUSLY** 

# B. Benches – Parks and Recreation Department

Emily England, Parks and Rec/Senior Director, is requesting approval to purchase 11 park benches at a cost of \$14,900. The benches will be used in Victory Park near the new dog park.

#### Treasurer Phillips -

 FYI – Walled Lake Consolidated Schools is having a millage on the ballot after they just had a millage in May 2024. They are trying to increase their supplemental millage, by voter approval, to 18 mills when the Headlee rollbacks over the last years have reduced the millage to 16.7461 mills. The difference between 18 mills and 16.7461 mills will go on the winter bill.

#### Trustee Sovel -

• If we were to install a fence, to stop residents from encroaching on township properties, would the resident have to pay for half the cost of the fence? Hans Rentrop, Township Attorney said no, we would have to put the fence on township property only. Trustee Sovel would like the Township Attorney to research archives to see if there is anything that speaks to this.

## Supervisor Gray-

- We should put money aside for marketing materials for the welcoming committee that we talked about.
- He is getting quotes on removal of a large rotted tree on Golf Lane Drive.
