# A. USF Rate Study - Dawn Lund

Dawn Lund presented an executive summary report for a long-term financial projection in the Water Department. The specific purposes of this long-term financial projection study are: 1) Determine Water utility's revenue requirements for fiscal year 2021. 2) Project rate adjustments needed to meet targeted revenue requirements.

Additionally, she presented and executive summary report for a long-term financial projection in the Wastewater Department. The specific purposes of this long-term financial projection study are: 1) Determine the Wastewater utility's revenue requirements for fiscal year 2021. 2) Project rate adjustments needed to meet targeted revenue requirements.

## **B. Sleeth Road Gravel Pit Brownfield Development**

Andrew Milia, Managing Member for Commerce Investment Company, LLC, gave a presentation and is seeking preliminary feedback from the Township Board for a 200-unit single-family home development on 157 acres on Sleeth Road in Commerce Township. He said the site is a former sand and gravel mine. They are proposing to complete the development under the Brownfield Tax Credit Program through the Oakland County Brownfield Authority in conjunction with the State of Michigan Land Bank. They are asking for input from the Township Board regarding its level of support of the Brownfield Tax option. Gary Jonna gave a presentation on the benefits to the Township.

Trustee Sovel likes the concept and the fact it is a low-density single-family development.

Trustee Berkheiser would like to see this move forward but would like to see a breakdown of how much of the money is true tax payer dollars versus project dollars.

Trustee Weber agrees with Trustee Berkheiser. He asked Mr. Milia if he is interested in purchasing the land to the east. Mr. Milia said he is not interested in that parcel. Trustee Weber is concerned whoever purchases the property to the east may also request a Brownfield Tax Credit because we approved one for this development. He would also like to see a breakdown of all costs and margins through the life of the project. With costs, he would specifically like to see the estimates of ordinary development costs versus extraordinary costs due to contamination.

Trustee Magner needs to review this further before she gives her support. Overall, she thinks this is a good use of the property.

Treasurer Phillips would like to see the numbers, rate of return and net present values before she gives her support.

Clerk Creech agrees with board members on the concept of the development and numbers.

## F. Library Staffing Recommendation

Alyson Lobert, Library Director, recommends combining the Youth/Teen Services Manager and the Adult Services Manager into one position: Head of Information Services. The Head of Information Services will supervise all of Commerce Township Community Library's librarians with an annual salary of \$65,000. In addition to this staffing modification representing a financial savings of nearly \$45,000 plus the added cost of benefits, this change will facilitate additional staffing flexibility and more collaboration between the two departments.

Trustee Berkheiser questioned the salary which is approximately 10% higher than what the Manager that will be taking this position made.
