This is contingent upon contract approval by the Township Attorney.

The original transfer that went to the attorney holding the property for sale once they were given authority by the court to sell it was dated in 2019 and they did not transfer the property to the new owners until 2020 but kept the date the same. She received a call from the title company saying they are in the process of preparing an affidavit saying the error on the property transfer should have been dated 2020 and it was filed timely with Commerce Township and Oakland County.

Supervisor Scott -

- The household hazardous waste day will be Saturday, September 19, 2020 from 9:00 a.m. to 1:00 p.m. at the Township Hall.
- The Township authorized the placement of gravel on all gravel roads.
- This Friday, PLM will be finished spraying Phragmites in the Township. They included additional areas that were not on the map.
- Residents are pleased with the Peninsular Park Paving Project.
- Trail cameras will be installed in some Township Parks in order to monitor vandalism.
- The Road Commission for Oakland County contracted with Hubbell, Roth & Clark to replace the culvert and overpass on Hayes Creek (Union Lake Road south of Wise Road). We are scheduled to have Union Lake Road paved from Cooley Lake Road south to Richardson Road.
- The Township received a check for several thousand dollars from the State of Michigan with the clause if it is not used for COVID-19 relief it must be repaid.
 We will return the check once we get reimbursed for COVID-19 expenses through the Cares Act.

Trustee Sovel -

 Asked for an update on the Outrun Hunger event. Supervisor Scott said they will have to abide by the Governor's order during the COVID-19 pandemic where you cannot have a gathering of more than 100 people outdoors. Trustee Berkheiser said Outrun Hunger has a Plan A & B in place in case the Governor's order is still in place.

 Asked what the status is for employee performance reviews. Janet Bushey said employee handbook and performance review distribution is scheduled for October 2020, if approved by the Township Board.

Jay James, P.E. Building Official -

- Removed several signs that were placed within the Township over the weekend and will remove the rest this week.
- Building is still going on relativley strong.

Jim Dundas, Fire Chief -

There was a large house fire started by a lighting strike on August 15, 2020.
 They received assistance from Walled Lake, White Lake, Milford, and West Bloomfield covered one of our fire stations for other runs.
