#### **ITEM 2:10-10 PUBLIC COMMENTS**

Keith Drews,1807 Union Lake Road, Commerce Township, MI, said on August 21, 2023 a hit and run accident occurred on their property. There is a sharp curve north of Wise Road on Union Lake Road. Over the years, many cars have missed the curve by going too fast. He is asking the Township to implement safety measures for this dangerous portion of Union Lake Road.

Ajay Raman, Oakland County Commissioner District14, provided the Board with updates.

- The budget for Oakland County was passed last month.
- Approved increases for public safety and mental health.
- Increased the staff at the animal control center.
- As Vice Chairman of Finance, he will create a team to review programs such as People's Express, transit, etc. to address the number of services we are receiving for the amount of money we are spending.
- We are continuing with the Tri-county broadband survey, to receive resident feedback, through the end of October 2023. Results will be compiled to identify the needs throughout the tri-county area and help guide the most viable alternative broadband options.
- There will be a 2023 Election Process Community Conversation held at the Novi Civic Center Council Chambers located at 45175 West 10 Mile Road at 7:30 p.m. on October 18, 2023.
- The Board of Commissioners has a Special Projects Fund. This is available to communities that have special projects they want for the benefit of the community.

Robert Long, 1342 Commerce Road, Commerce Township, MI, said during the budget meeting held two weeks ago, he heard a comment from a trustee, that he believes was directed toward one Township employee, that the person hired by the Township was satisfied with the salary they hired in as. He stated the Township has the best team of directors and employees that they have ever had in the last 30 years and he feels it is important to retain them at a competitive salary rate.

#### **ITEM 11:10-10 PURCHASES**

#### A. Library Generator

Alyson Lobert, Library Director, said the Library Advisory Board recommends the Township Board approve the purchase of an emergency generator in the amount of \$209,900 from Corby Energy Services, Inc. 2023 budget: \$100,000 budgeted for a generator in 2023 and, 2024 budget: \$110,000 proposed. She said this will assist residents by having a safe place to go when their electricity is out and, if they work from home, they would have access to the Township's internet.

Discussion took place on the need for a generator at the library when we already have generators at various Township buildings that can serve the residents in the event of a power outage.

Clerk Creech said the early voting regional site for Commerce Township, Walled Lake, and Wixom residents is at the Commerce Township Community Library. If there is a

power outage during that time, having a generator would allow the voting process to continue uninterrupted.

**MOTION** by Magner, supported by Phillips, to approve the purchase of an emergency generator (250kw) in the amount of \$209,900 from Corby Energy Services, Inc. (CES Job No. 4033-8222 dated September 11, 2023) including the preventative maintenance 5-year annual service/inspection for \$10,975, as presented. \$100,000 will be paid from the 2023 budget and \$110,000 will be paid from the 2024 budget.

Dawn Raye, The SILO Ranch of Commerce, was present. She said she ordered fencing to put around the property. The programming and scheduling calendar will be available soon.

#### Trustee Weber –

 Chief Dundas, Trustee Berkheiser and I reviewed the Excel spreadsheet, made by Trustee Berkheiser, to make sure we are on track with the expected union contract impact, operating costs, and capital expenditures through the life of the SAD. We should continue to use the spreadsheet through 2031 (the life of the SAD).

#### Trustee Berkheiser –

 Will there be a presentation before the Township Board on the sewer/water study? Treasurer Phillips said Dawn Lund, Utility Financial Solutions, was not available at this time to give a presentation. The rates are consistent with her latest update; therefore, no changes are needed and the rates are good for a couple of years. She will come in and give a presentation if requested by the Township Board.

## Treasurer Phillips -

 We would like to make a draw on Michigan Finance Authority before the end of the year. Jason Mayer said he is working on this and will send it to her tomorrow.

## Trustee Magner –

 We have approached The Road Commission for Oakland County for some basic requests and they seem to say no to a lot of our and resident's requests when it comes to items such as no turning lanes, green arrows, etc. Supervisor Gray said they did not say no, they said they need a study done in order for them to take action on requests.

# Supervisor Gray -

- We received the signed agreement for the 2M HUD grant.
- He would like direction for our Ordinance Officers regarding encroachments on Township property. Trustee Sovel said if one option is to allow a resident to use our property, they should provide the Township with an insurance policy on the portion of Township property. Trustee Weber said we should not allow a resident to encroach on Township parks, and a consistent approach should be taken for parks property and Township owned parcels. We need to survey properties (approx. 15 properties) that are encroaching on Township property and look at them individually and then send the resident a letter advising them of the Township's course of action.
