In the absence of Ms. Grever, David Campbell, Planning Director, and Jay James, Building Official, spoke of her qualifications that could assist the Zoning Board of Appeals as an alternate member.

ITEM 4:5-11 CONTRACT AWARDS AND AGREEMENTS

A. Request of Commerce Downtown, LLC to Extend Option Agreement Bruce Aikens, Developer with Robert B. Aikens and Associates LLC, was present to request a one-year extension of the Option Agreement for Five & Main due to delays because of the COVID pandemic.

Trustee Weber asked Mr. Aikens if he will come back to the Township Board for another one-year extension for Phase 2. Mr. Aikens answered yes.

B. Plante Moran Cresa Contract Extension

Jim Dundas, Fire Chief, recommends the contract extension for Fire Station #3. He is not asking for any additional funds because there was a contingency built in to the contract.

ITEM 4:5-11 CONTRACT AWARDS AND AGREEMENTS (Plante Moran Cresa Contract Extension continued)

Kevin Donnelly, Plante Moran Cresa, advised the Board that the contract included 750 total hours over a duration of 20 months. Over the contract period they have expended 880 total hours through March 31, 2021. They are not seeking any additional compensation through the end of March 2021. The project's completion date is now the end of October 2021. He is proposing an extension of the contract for the new Commerce Fire Station #3 for an additional seven months at a cost of \$46,000.

Trustee Berkheiser asked Mr. Donnelly if he feels confident the extension will take us to the end of the project. Mr. Donnelly said he is confident it will unless there are unforeseen issues.

MOTION by Berkheiser, supported by Weber, to approve the request to amend the contract with Plante Moran Cresa to extend their services through completion for the Commerce Fire Station #3 at a cost not to exceed \$46,000 and authorize the appropriate signatures.

D. Haggerty Road Sidewalk Connection Between On The Dunes Trailhead and Michigan Airline Trail

David Campbell, Planning Director, advised the Board that Adam Zimmerman of On The Dunes (2055 Haggerty Road) has volunteered to allow a portion of his business' parking lot to serve as an official trailhead for the Michigan airline Trail. A plan was developed to construct an ADA-accessible 5-foot concrete sidewalk between the southeast corner of the On The Dune parking lot and the Airline Trail, including across the frontage of Munro Collision (1955 Haggerty). The Planning Department and the Township Engineer are seeking approval to dedicate \$30,000 from the sidewalk fund toward the Haggerty Road Sidewalk.
