David Boersma gave a presentation on the new Sheriff Substation. He displayed the
layout of the interior and exterior of the substation on the overhead screen. Bids for
construction are due on Sept 29, 2022. Assuming there are no issues, the approximate
start date for construction is November 1, 2022. He anticipates it will take approximately
7 months to complete the project.

ITEM 2:8-16 PUBLIC COMMENTS

Supervisor Gray opened Public Comments.

Pam Jackson, 5736 Lancaster Lane, Commerce Township MI, asked if there will be an elevator or escalator to the 2nd floor for the Sheriff Substation. David Boersma answered yes. During the July meeting she brought it to the attention of the Board that the lake frontage at her home was not treated for weeds. She thanked the Township because the contractor did come out and treat her lake frontage.

Hilary Pietila, 2900 Colt Ct., Commerce Township, MI, Country Hills HOA Board member, sent in a petition signed by the majority of homeowners in Country Hills advocating against roadway connectivity between Country Hills and The Preserves of Proud Lake. They wish to maintain the integrity of this subdivision. There will be increased traffic if The Preserves of Proud Lake is approved. She has safety concerns because of this and the fact Country Hills does not have sidewalks.

Greg Garner, 3791 Stallion Way, Commerce Township, MI, he is in agreement with Ms. Pietila. He is concerned about the safety with extra traffic. Also, if the subdivisions will be connected then The Preserves of Proud Lake should pay the amount specified in their Master Deed.

Shelley McQuillen, 2995 Chickory Lane, Commerce Township MI, thanked Jay James and Mr. Burdine for meeting with the residents that live east of the proposed condominiums. They answered their concerns regarding the water run-off. She is requesting that when the subdivision is built and the bylaws are written for the HOA, it includes language that addresses regular maintenance and engineered inspections done on the retention pond. They would like a guaranteed bond from the builder that will be significant enough to take care of any potential problems that may arise from the retention pond.

Adrienne Garner, 3791 Stallion Way, Commerce Township MI, is requesting her roads be treated in a similar manner as other subdivisions with emergency access points.

Supervisor Gray advised the public that the Oakland County Board of Commissioners voted to place a countywide transit millage on the November 8, 2022 ballot. Should Oakland County voters approve the .95 mills this means it will cost residents .95 cents for every \$1,000 your house is worth. The tax revenue this will generate from Commerce Township residents will be 2.3 million dollars and will go to Oakland County to expand mass transit throughout all of Oakland County. Currently, the Township

E. Roll Resolution – Fox Lake Aquatic Weed Control SAD 2023-2032 Supervisor Gray opened the Public Hearing.

Pam Fiani, 5250 Lancaster Lane, Commerce Township, MI, said when she was approached to put money in for Fox Lake she was told it would be less than \$100. The first year it was \$387. Now the 10th year it is \$193. When she reviewed the papers that were mailed to her regarding the SAD, her lot number was not included. She called the Township Hall and found out she only received 1 page. She does not know how many people voted in support of this SAD and how many people did not. She is the second house off of Wise Road and is the furthest from Fox Lake. She was told the treatment doesn't even work on her frontage because of the distance from where the product is placed in Fox Lake. It gets so diluted by the time it gets to her house and it does nothing for the weeds. She feels she should get at least a 50% discount on the price because of this plus she has no access to Fox Lake to launch a boat. Supervisor Gray will check into this.

Dan Zatsick, 5725 Kalkaska St., Commerce Township, MI, said he also did not receive all of the paperwork. He asked what the cost is. Supervisor Gray said the cost is \$207.16 for 2023 with a 5% increase each year to 2032. He wanted to know if this will be sent out for bid to other companies to see if we are getting the best deal. Supervisor Gray said if the majority of the residents would like the Township to do that, then he will put it out for bid.

Hans Rentrop, Township Attorney, said it appears some residents of Fox Lake did not receive all of the paperwork because page 3 was missing. This also happened with Lower Straits Lake residents. He recommends the Public Hearing remain open until the next Township Board meeting and send out another notice to all residents.

H. Establishment Resolutions – Chickory Lane Maintenance SAD 2023-2032 Resolution and Paving SAD Resolution

The Public Hearing remained open from the July 12, 2022 Township Board of Trustees meeting.

Jay James, Building Official, reviewed the costs for 2023. I was able to get in touch with the original, current applicator for dust control who did send in a bid but it went to the spam mail. I looked at his bid and we are going to contract with him because the cost is much lower. This will save us approximately \$1,200 each year.

I contacted the current snow plow contractor to see if he will extend his bid for one year. He said he would extend it but he did have a cost increase of around 20% which comes out to be \$1,800 for 2023. If approved by the Board, I recommend the current contractor at \$1,800 for snow plowing for the 2023 year and then next year when we bid out all of our SAD snow plowing we include Chickory Lane.

Total cost for paving,1 dust control, 2 gradings and snow plowing is \$446 for 2023.

ITEM 3:8-16 PUBLIC HEARINGS (Establishment Resolutions – Chickory Lane Maintenance SAD 2023-2032 Resolution and Paving SAD Resolution continued) Maintenance is \$330 for 1 dust control and \$400 for 2 dust controls per parcel per year. The dust control goes up to the "Y" in the road, which is the 5th home on Chickory Lane.

I recommend a 3 year contract for grading and then go out for bid to see if we can get a lower cost.

There were two petitions circulated – one for maintenance and one for manintenance with the paving included.

The Township attorney and Jay James recommend two separate resolutions for the SAD. One for paving and one for maintenance.

Shelley McQuillen, 2995 Chickory Lane, Commerce Township MI, is pleased the Township will pay for their portion of the road. She said that Jay James assured her that the water will not run down the road. She is requesting one dust control. If money is left over from the SAD she would like it returned to the residents that paid into the SAD.

Rachel Jeziorski, 2940 Chickory Lane, Commerce Township MI, said the majority of homeowners on Chickory Lane signed both petitions that include 2 dust controls.

Sherry Watkins, 2810 Chickory Lane, Commerce Township MI, she is in support of 2 dust controls as stated in the petitions.

Supervisor Gray closed Public Comments.

Trustee Sovel questioned why we are taking 1 dust control out if they asked for 2 in the petition.

Don Jeziorski, 2940 Chickory Lane, Commerce Township, MI, is in support of the paving. The majority of the residents are willing to pay for what is in on the original SAD. The Township should contribute to the cost of the road maintenance.

William Watkins, 2810 Chickory Lane, Commerce Township, MI, is in support of the paving in the original SAD. If the Township sells their piece of property, does that mean whoever they sell it to does not have to chip in for the road?

Dana Swaney, 2960 Chickory Lane, Commerce Township, MI, if the Township sells their property does the road have to be moved to the east? Jay James said no, there is an easement that remains with the property. Dana Swaney is in support of the paving.
